French Language Early ON

I am very pleased to highlight that our DSSAB's EarlyON program has been in contact with The Parry Sound French Language school (École publique aux Quatre-Vents) regarding an opportunity to start an EarlyON satellite program at that school. As a pilot, we will be sending out our French language facilitator to offer a mini program once in May and again in June. This will allow our program supervisor to assess the interest level and the space to explore whether a satellite program is viable.

2024 Federal Budget Highlights

On April 16, Deputy Prime Minister and Finance Minister, Chrystia Freeland, delivered the **2024 Federal Budget**. Of note:

Total spending in the Federal Budget will come in at \$535 Billion in spending against \$497.5 Billion in government revenues.

Of note:

- Launching a \$1 Billion Child Care Expansion Loan Program to build more child care spaces and renovate existing child care centres.
- Expanding the Canada Student Loan Forgiveness Program to include early learning and child care educators who choose to work in rural and remote communities.
- A new Public Lands for Homes Plan to use all tools available to unlock 250,000 new homes by 2031 on public lands. This also includes Canada Post properties, National Defence land, and office buildings.
- Building more rental apartments faster with an additional \$15 Billion in new loan funding for the Apartment Construction Loan Program, bringing the program's total to over 131,000 new homes by 2031-32.
- Providing a \$400 Million top-up to the \$4 Billion Housing Accelerator Fund which is already fast-tracking the construction of over 750,000 new homes over the next decade thanks to 179 agreements with municipalities, provinces, and territories.
- Launching a new \$1.5 Billion Canada Rental Protection Fund to protect and grow the stock of affordable housing in Canada.
- Providing \$1 Billion for the Affordable Housing Fund to build affordable homes and launch a permanent Rapid Housing Stream to build on the success of the previous three rounds of the Rapid Housing Initiative.
- Investing an additional \$1.3 Billion for *Reaching Home: Canada's Homelessness Strategy* to address homelessness and encampments..
- Accelerating the construction and upgrading of housing-enabling infrastructure by providing \$6 Billion over 10 years through a new Canada Housing Infrastructure Fund.









Ontario Works Intake - Social Assistance Digital Application (SADA) & Local Office Ontario Works Applications Received





ODSP Participants in Ontario Works Employment Assistance


Employment Assistance & Performance Outcomes






MyBenefits Enrollment 2024

Resolution:

THAT the Board direct staff to award the tender for replacement of windows, screens and metal doors to 22A Belvedere Ave, Sunset Court, Parry Sound, ON to Design Roofing/Northern Glass & Metal in the amount of \$995,000.00 plus additional pricing \$217,000.00 for a total of \$1,212,000.00 (plus HST).

Report:

The DSSAB, with assistance from Housing Services Corporation, has prepared a tender that will address the needed replacement of all existing windows, screens and metal doors at the Sunset Court, Seniors Building in Parry Sound.

Scope of Work

The facility is a 6-storey apartment complex. The exterior vinyl windows within the units and exit stairs were replaced in 1997, making them approximately 26 years old and in fair to poor condition as reported by the architect. The ground floor common areas and front entrance aluminum windows appear to be original to the building and are in fair to poor condition as reported by the Architect. The exteriors door varies between 25 to 45 years in age and was noted to be in fair to poor condition by the Architect. The life expectancy of vinyl windows is 20-25 years while the life expectancy of aluminum windows is 40 to 50 years. As reported by the Architect, all windows and doors have reached the end of their life expectancy. Windows will be replaced with double pane aluminum, increasing the life expectancy of all windows to 40-50 years, along with increasing energy efficiency. Store front common area windows, and exterior doors to be replaced. Replacement of all interior and exterior sills to be replaced, as they are in poor condition. It was recommended to combine all scopes and replace ground floor aluminum windows and exterior doors now, saving on high energy costs and significantly increased replacements costs in the near future, due to having already reached their life expectancy. Additional pricing was requested from the bidders for the ground floor common areas/front entrance windows and doors/door frames to allow options based on available funding.

Representatives from all Bidders were in attendance.

Evaluations

All bids underwent a review for compliance with the mandatory requirements outlined in the ITT.

While Enerfrees Window and Wall Systems submitted all of the mandatory requirements, it was later discovered that the subcontractor they submitted, who was the window installer and would be doing the majority of the work, was dissolved. Enerfrees Window and Wall Systems' bid was rejected on this basis.

Tenders were received by Housing Services Corporation (HSC) on April 3rd, 2024 at 2:00 pm for the PSDSSAB Exterior Window Replacement, Screen, and Door Replacement project. The bid submission and vendor score were reviewed by HSC. All submissions were reviewed and evaluated by Mitchell Jensen Architects (MJA), for which you will find attached a Tender Evaluation document. The following is a summary of the tender evaluation for the above project.

It is our understanding that the District of Parry Sound Social Services Administration Board would like to consider incorporating the following separate prices into the base bid contract:

- Separate Price #1 Replacement of all existing thermally broken aluminum screen system including hardware work.
- Separate Price #2 Replacement of all existing insulated hollow metal doors and frames.

We believe that incorporating both separate prices will help ensure that all of the facilities windows and exterior doors are renewed at once and provide the building openings with an additional 30 to 50 years of life.

The base bid included for the supply and installation of aluminum windows which carries a lifespan of 40 to 50 years with proper care and maintenance versus the life time expectancy of 20 to 25 years of the vinyl (plastic) counterpart. We highly recommend proceeding with the base bid aluminum windows.

Irregularities

If a bid is qualified, informal or non-compliant with the requirements set out by the Bid Documents, the Owner has an obligation to reject this bid, because to do otherwise is considered unfair to other, compliant bidders. Therefore, each irregularity must be considered, as to whether the extent of irregularity renders the bid informal. The bid documents indicate that the determination of informality will be at the sole discretion of the Owner; however, such judgement must be objective and reasonable to all bidders.

We have found no irregularities in all submitted documents from Designed Roofing / NGM, W.S Morgan Construction, and Quinan Construction.

Upon review of the low bid from Enerfrees Window and Wall Systems, we found their Bid Price to be less than half of the second highest bidder. Although no other irregularities were identified, this price spread stands out as our estimate provided in the DSSAB Window Replacement Report was listed as \$985,595 for the Supply and Installation of double-glazed aluminum windows.

As HSC has not provided review criteria, Enerfrees cannot be disqualified based on bid price alone. In these circumstances, the MJA team might suggest that HSC holds a meeting with the low bidder to review their submission as well as the tender documents to ensure that all aspects of the project are being considered and provide the low bidder an opportunity to withdraw their submission should they have failed to include some of the scope of work in their bid price. We also reviewed Enerfrees Schedule C, Subcontractor #1 listed as 'Rominline Corp, 67 Harold Lawrie Lane, Markham, L3T 5W6' and note that based on a brief internet search, it would appear that the listed subcontractor may be a dissolved company. Upon further investigation by HSC, Enerfrees has confirmed that 'Rominline' is indeed a dissolved company.

Based on the provided information, should HSC determine that Enerfrees naming a dissolved company as their subcontractor for the installation of the windows constitutes an irregularity and chooses to disqualify Enerfrees, then we see no reason not to award the contract to the second lowest base bid bidder Designed Roofing. The final determination however, is in the hands of HSC and its client..
